GUIDANCE NOTES

APPLICATION FOR A VOLUNTARY INDIVIDUAL VEHICLE APPROVAL (IVA)

FOR A WHEELCHAIR ACCESSIBLE VEHICLE (WAV) CONVERTED TO CARRY NO MORE THAN 8 PASSENGERS IN ADDITION TO THE DRIVER – M1 WAV

VOLUNTARY IVA – The Voluntary IVA test for a wheelchair accessible vehicle (WAV) only, is being provided to confirm the M1 status of a vehicle that is intended to be licensed as a Class B taxi, where the vehicle owner is unable to produce evidence of the vehicle's statutory M1 WAV approval.

A vehicle that has been converted to carry an occupied wheelchair will only be accepted for the test where there is evidence that it has been originally constructed and certified as category M1, N1 or M2. (The vehicle category is generally recorded on the registration document V5C).

Note: Where the vehicle is yet to be registered in the UK, confirmation of type approval (M1, N1 or M2) may be obtained from the original vehicle's Certificate of Conformity or Approval Certificate (if conformation is obtained via either document, please send a copy of that document to DVA along with your completed application form)

The vehicle is required to comply with the 'Normal' test requirements for an M1 WAV; the converted parts of the vehicle will generally be subject to the 'Basic' test requirements. The test requirements are referred to in the Individual Vehicle Approval (IVA) Manual for Category M1 (Passenger Vehicles), located at the web address below:

Before you apply for a Voluntary IVA test you MUST ensure that the WAV is capable of readily complying with all related taxi licensing legislation, including The Taxi Licensing Regulations (Northern Ireland) 2015 and The Taxi Accessibility Regulations (Northern Ireland) 2015 in particular. 2a. When will the vehicle be available for test?

Please give the date from when the vehicle will be available for test. Please enter your preferences, or if no preferences, enter 'any'. An appointment will be given as close as possible to your requirements. Occasionally, this may be at short notice (i.e. within three working days).

These test times will be available from 9am to 4pm Monday to Friday.

3. VEHICLE DETAILS

3a (i). Vehicle Registration Mark.

If the vehicle is registered in the UK enter the vehicle's registration number.

3a (ii). Vehicle Chassis Number.

Also enter the Vehicle Chassis Number (vehicle identification number (VIN)). You can find the vehicle chassis number on the manufacturer's information plate – located under the bonnet, around the door opening, or where previously registered in another country, on a previous registration document. Please make sure you write the number in **full**.

3c. Type approval category of original vehicle?

A vehicle that has been converted to carry an occupied wheelchair will only be accepted for the test where there is evidence that it has been originally constructed and certified as category M1, N1 or M2. (The vehicle category is generally recorded on the registration document V5C).

Note: Where the vehicle is yet to be registered in the UK, confirmation of type approval (M1, N1 or M2) may be obtained from the original vehicle's Certificate of Conformity or Approval Certificate (if conformation is obtained via either document, please send a copy of that document to DVA along with your completed application form)

3d. What is the date of manufacture?

You can get the date your vehicle was made from the vehicle manufacturer's information plate or from the manufacturer.

3g. Is the gear box Manual/Automatic?

'Automatic' includes automatic gear boxes that can be used in manual mode.

3h. If a registered vehicle, has it been modified since it was first registered?

Please provide details of all modifications made to accommodate an occupied wheelchair/s - refer to changes to the vehicle body (including the fitment of a passenger partition, generally required to support a rearward facing wheel chair), changes to passenger seating arrangements, and the nature of the wheelchair and wheelchair occupant restraint systems (these systems must comply with BS ISO 10542).

In addition, please provide details of any changes to the engine power output or transmission. Minor changes such as a change of colour, trim specification need not be included.

3i. How many designated seating positions does the vehicle have including the driver's?

A designated seating position is a seat used for normal use when the vehicle is travelling on the road.

In respect of most production vehicles seating positions can be determined by the number of seat belt anchorages. Where a vehicle is fitted with a bench seat, the number is determined by dividing the cushion width by 400mm.

4c. Has your vehicle been converted from a goods vehicle that has a design weight of 1500kgs or more?

If 'YES' does the vehicle also have a seat reference point (of the lowest front seat) of more than 700mm above the ground?

A passenger car would normally have a reference point below 700mm. For guidance only, it can be assessed with the front seat (if adjustable) in its lowest, most rearward position and by placing a rectangular block measuring 136mm long and 53mm high onto the back of the seat cushion against the back rest. The forward upper edge is the height of the reference point. If the measurement is close to the critical point (that is, above 700mm), you should get advice from us, the manufacturer or a designated Technical Service (Test Laboratory).

- **4f.** Where the converted vehicle has been fitted with additional seats having integral seat belt anchorages and those seats have <u>not</u> been provided by the original vehicle manufacturer, evidence of compliance with the seat strength and positional requirements of Directive 76/115/EEC for a category M1 vehicle (passenger vehicle with not more than 8 seats in addition to the driver's seat) is required. Applicants should submit:
 - (i) the Seat Belt Anchorage 'Compliance and Compatibility Declaration' (DVA-VIVA 3), and
 - (ii) a Seat Belt Anchorage 'Installation Declaration' (DVA-VIVA 4)

Both declarations should be completed by the vehicle converter (the declaration forms are located at the web address below:

Where it is not possible to obtain the converter's declarations, alternative evidence of M1 seat belt anchorage compliance will be required. This evidence may be in the form of a compliance declaration provided by e.g. the seat manufacturer, or a third party involved in the conversion of motor vehicles (see Section 19 of the IVA Inspection Manual, located at the web address below:

Note: Where rearward facing seats with integral seat belt anchorages have been installed, it is acceptable if those particular seats comply with the strength and positional requirements for a category M2 vehicle.

6. PAYMENT DETAILS - CANCELLATION & REFUND

Should you wish to **cancel** the IVA application after it has been processed and the test appointment has been made, a fee of £100 will be retained and the remaining amount refunded.

If you give <u>more</u> than 3 working days notice prior to the appointment date you can request a later appointment (If you do not request a later appointment, a fee of £100 will be retained by the DVA and the remaining amount will be refunded to the payee).

If you give 3 working days or less notice prior to the appointment date the whole fee will be forfeited.
