

# DRIVER CPC NATIONAL VOCATIONAL TRAINING (NVT) CONCESSION

The NVT concession is valid from the start date of the NVT programme or from when the driver acquired their vocational driving licence, whichever is the most recent. The Driver CPC tests can be deferred for either a maximum of 12 months from this date or for as long as the driver remains on the NVT programme (whichever is the shortest).
